WELCOME BACK!

Every year at this time of year we welcome back our readers to our annual Top 100 Most Influential People in Accounting list, and we welcome back some of the members of the previous year's list, too.

But not all of the members of the previous year's list - or all of our readers. Every year, it's a different list, and a different set of readers. Because accounting is changing, growing and evolving; it's a work in progress, and so our list has to be a work in progress, too,

As technology grows more important in accounting, we include new IT experts; as new regulatory bodies are formed, we add new regulators; as more Millennials and Gen Ys rise to positions of importance, more of them will appear among the Top 100; as the profession explores more new specialities, we'll add experts from those fields; and as more women and minorities (hopefully) join the profession, we'll add more women and minorities.

Our list is different from the profession mainly in that, to make room for the new arrivals, we have to remove some previous members. But we must move with the times, as the profession does, and make room for new people, new thoughts, new ideas and new visions. For a profession that's supposed to be conservative (even staid), accounting welcomes an awful lot of change into its ranks. And so each year our editors make a list of the people playing the biggest roles in the ongoing work that is the accounting profession — and then we whittle it down a little, and then a little more, and then a lot. Eventually, we get to 100.

But even as we do, we're working on another list, our "Ones to Watch," up-and-comers who have started to shape the profession but are still gathering influence, ready to step up at some point in the future.

With that thought, we'll leave you to enjoy this year's list now. We've got to get started on next year's.

Accounting's biggest issues

As always, we asked our T100 what the most important issues facing the profession are, and as always, they came back with thoughtful answers, with much attention focused on succession planning, complexity, keeping up with change, and — gulp — the relevance of the profession as a whole.

People are not going to like this, but I'd say: relevancy. Many CPAs are nothing more than high-priced bookkeepers, and unless they move away from the idea that they're historians with bad memories, who can only report on the past ... their future is in peril. — Ron Baker

Relevance. Accountants sell a number of services that are becoming more and more automated. Additionally, modern business owners find lagging financial statements to be of questionable value. — Michelle Golden

The danger of our profession becoming obsolete. Our profession is moving towards commoditization. There is the potential that we will no longer be needed. — Jason Blumer

Relevance in the face of inertia. ... In the words of Jack Welch, "If the rate of change on the outside exceeds the rate of change on the inside, the end is near."

— Jon Baron

The notion of relevancy is the most impactful challenge facing the profession. — Stephen Chipman

The relevancy of our audit service/product When almost every set of financial statements are correct, yet the world experiences the biggest financial surprise in decades, something is wrong.

— James Turley

Relevance with our clients. As a profession we need to provide real value and do more to help businesses succeed.



The forecast for tax reform

We asked the T100 if we were likely to see large-scale tax reform in the next year; they split the issue — three ways.

I do not believe so. Tax reform is like a balanced budget: Everyone says they want it, but everyone wants a different version. — Iohn Ams

The last time we saw major federal tax reform, in 1986, it was a product of Democrats and Republicans from both houses working together to effect change. No such working relationship currently exists. — Joanne Barry

I do not think we will see large-scale tax reform because it is too risky. We probably need significant changes to our tax system, but to do so in our current economic climate would be completely reckless and irresponsible because our standard economic models cannot predict the — Parnell Black end results.

Not likely - there are no political leaders who can effectively communicate how and why this needs to be done, and the special interests are so entrenched, making any changes slow and incremental.

- Tom Hood

The likelihood of the passage of large-scale reform in the next 12 months is extremely remote. ... The interest in corporate and international reform will continue but little will be accomplished through the end of 2012 - setting the stage for more serious activity in 2013. Congressional hearings on corporate and international reform are likely to take place in the first half of 2013, but passage of legislation is unlikely until the latter stages of 2013 or possibly in 2014. — Edward Karl

The last time we achieved meaningful tax reform was during a period of divided government, but tax reform is going to be a much harder lift for either of the parties this time, and that makes it nearly impossible to achieve. - Ralph Thomas

Our clients repeatedly tell us in surveys and conversations that they believe nothing significant will happen on the corporate or personal tax front before 2013 — and I agree. — John Veihmeyer





It is unlikely that large-scale reform on the order of the Tax Reform Act of 1986 is in our future in 2013. However, it does seem likely, if not necessary, that some less extensive reforms will take place to reduce the gap between revenues and expenditures. - J. Russell George

Large-scale tax reform will not occur in the next year. but it will most likely occur in the next four years. ... Reform will most likely be a modification to our system that will reduce complexity for lower-income taxpayers and provide economic business incentives. ... What will most likely emerge in the next 10 years is a universal approach to many state tax issues, in particular sales and income taxes related to interstate commerce. - Jim Buttonow

Large-scale tax reform is not likely until 2013. Even then, the priorities and impact on a new Tax Code will need to be assessed in the context of the country's entire fiscal situation. There is no question that largescale tax reform is needed; the question of timing and the political will to take on this national need remains open.

I think it is coming but it may not be in the next year. I think we will see it in the next five years. The last serious tax reform effort took place in 1986, meaning we are over-— Angie Grissom due.

Both Obama and Romney have such different plans for both income and estate taxes, so the outcome of the election will have a significant impact on tax reform in 2012. - Tom Marino

There is one area where consensus is building: Our corporate tax rate is one of the highest of the developed economies, and both sides acknowledge the need to lower that rate As a tradeoff to a lower rate, the tax base will be broadened by eliminating many of the specialized industry and exporting incentives. — Krista McMasters

The possibility of large-scale tax reform is high for a number of reasons. Probably the most important reason for corporate tax reform is the perceived need to reduce the corporate tax rate However, given the current economic climate (large deficits, sluggish economy, expiring Bush-era tax cuts), simply reducing the rate is unlikely. Rather, it would need to be coupled with other reform to maintain the tax base. On

the other hand, the current political climate does not bode well for any agreement on major tax reform. — George Farrah

Major tax reform simply has to happen -the stakes are too high to continue to kick the tax can down the road. -Paul Caron

Yes, we will see large-scale tax reform in the next administration, regardless of who wins the presidency. We will have to raise taxes, particularly on the wealthy Otherwise we have to cut military expenditures and Social Security, neither of which are popular. Obamacare will not be overturned - it's already too far ingrained.

— Chris Frederiksen

Call me a dreamer, but I do think we will see tax reform next year or maybe shortly thereafter. Our tax system has gotten so complicated that it is difficult for anyone to defend it.... We will get tax reform sooner than later, but we should not confuse reform with simple, fair or less expensive.

- Roger Harris

Yes, expect positioning to accommodate health care changes, and movement towards more balanced tax and spending ratios. If elections make for sweeping changes, there will be sweeping legislation. If elections don't make for sweeping changes, there will be actions forced by the fiscal cliff provisions. — Randy Johnston

The tax laws that are about to expire will probably get extended; large-scale tax reform will happen after the presidential election. Most likely the corporate tax rate will be reduced to encourage companies to bring jobs back to the U.S.

— Lana Kupferschmid

The budget deficit will force the president in 2013 to start making changes, as the borrowing cannot go on forever. Thus, cutting spending alone won't be enough and we will — Joel Sinkin see tax reform.

I believe that it is extremely likely. ... I am hoping we see a balance of spending cuts, tax increases and changes to some of the top tax breaks.... Instead of focusing on massive change to just one area, I think if we made smaller changes across all areas, it would lead to a healthier economic climate.



OTW 100 is not enough

Apart from the fact that everyone who isn't included in the list will hate us, there is one major problem with having only 100 people on our Top 100 Most Influential list: It's not enough.

The public accounting profession has grown too large, and reached into too many areas, for all the vectors of influence to be accounted for with just 100 people. Some people of influence will, inevitably, be left off.

Still others, though, may not make the list because their influence is not fully formed — they're approaching influence, but not yet wielding it at the level of an official member of the T100. These are our Ones to Watch, and this year's class is impressive.

We'll start with a group you'll literally watch — the viral video team from Top 100 Firm WithumSmith+Brown: marketing director Rhonda Maraziti, senior marketing coordinator and choreographer Sarah Cirelli, and creative manager Jin Young Park, whose two videos have done more to dispel stereotypes about accountants than just about anything we can think of, as well as making a star of their lead dancer, managing partner Bill Hagaman. We can't wait to see what they make Bill do next.

Hagaman himself is One to Watch, though more for the leadership he displays than for his dance moves. There are a number of other firm leaders we're keeping an eye on, many of whom have either recently come into their positions, or are due to step up in the future as part of succession plans. Joe Adams of McGladrey is one of the former, with big plans for his No. 5 firm, including a major push to the West, as is Ted Dickman, who recently took the helm at Midwest power BKD. Among the latter, Wayne Berson is due to take over BDO from long-time chief Jack Weisbaum this fall; and Mark Weinberger is due to be global chief of Ernst & Young when current chief Jim Turley steps down in June of 2013.

Meanwhile, Karen Abramson is due this month to take the helm at CCH, succeeding long-time Top 100 People member Mike Sabbatis. Also on the move among vendors was conference, event and Twitter mainstay Kim Hogan, who left Fujitsu for workflow leader XCM earlier this year.

Not changing jobs, but changing how the profession uses technology, are a few more Ones to Watch from different vendors: Kasey Bayne, the "accounting ambassador" from cloud-based solution provider FreshBooks; Jamie Sutherland, the U.S. face of New Zealand's cloud solution, Xero: Therese Tucker, whose BlackLine Systems is changing period closes at companies across the country; and Pascal Van Dooren, who will be showing accountants how to add a sales tax practice, with tools like those from the company he represents, Avalara. Amy Vetter, meanwhile, deserves watching at cloud accounting pioneer Intacct, where she'll be the contact for the accounting profession. Finally, we'll be interested to see what long-time Thomson Reuters player Teresa Mackintosh does now that she's made the move to CCH.

Among practitioners, Michael Hsu of DeepSky is becoming the face of bold young firms, while Freed Maxick's Emily Burns and Rea's Katie Tolin are considered two of the sharpest accounting firm marketers in the field. And when we need a laugh, comedian-accountant Greg Kyte proves that that hyphenation is not an oxymoron, while sliding in some forwardthinking ideas as co-host of THRIVEal presentations with Jason Blumer. On the tech side, Donny Shimamoto of Intraprise TechKnowledgies is making a name for himself, not least as chair of the AICPA's IT Executive Committee.

Within the institute itself, Heidi Brundage and Jina Etienne are two rising stars. with growing reputations as speakers and representatives of the next generation of CPAs. At a different professional organization, the National Association of Enrolled Agents, senior director of government relations Robert Kerr has become a prominent voice on tax issues.

And on the regulatory front, Rep. Charles Boustany, R.-La., has shown a decided interested in tax matters, while the newest board member of the Public **Company Accounting Oversight Board,** Jeanette Franzel, is a welcome addition to the overseer.

Finally, we recommend paying attention to Francine McKenna of the re: The Auditors blog, who has expanded her remit beyond auditing to writing about business and the economy at large, and in a number of venues.



We've run out of puns

Each year, we ask the candidates for the Top 100 People to name the three people they think are the most influential, and every year, Barry Melancon tops the voting — so much so that we've run out of clever headlines to reflect his truly unparalleled influ-

ence on the profession.

What makes it even more impressive is the number of different reasons people named him as influential. As head of the American Institute of CPAs, he is naturally a spokesman for the profession, and many cited him as such. Others referred to his wide-ranging knowledge of the issues, and still others named his influence on a variety of ongoing initiatives: IFRS, the CGMA, the Private Company Council, and so on.

It's important to note that not all the references were positive — not everyone agrees with him on the major issues, or approves of the initiatives the AICPA has undertaken on his watch (most notably the CGMA) — but that, too, is a measure of influence.
